The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

#### FINDINGS OF FACT

- Respondent Rodnetta S. Jagers (dob 09/20/1974) is licensed in the State of Wisconsin as a Barbering and Cosmetology Manager, having license number 81-32863, first issued on June 15, 2009 and current through March 31, 2013. Respondent Jagers' most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 8559 North Granville Road, Apt. 210, Milwaukee, WI 53224.
- On or about November 17, 2011, the Department received information regarding 2. a criminal conviction for Respondent Jagers. Division of Enforcement case number 11 BAC 171 was subsequently opened for investigation.

- 3. Court records obtained during the course of the Department's investigation revealed that in September 2010, Respondent Jagers was charged with a felony, Misappropriate ID Info Obtain Money (Ozaukee County Case Number 2010CF000206). On or about August 30, 2011, Respondent Jagers pled guilty to the charge and was sentenced, in part, to 18 months probation.
- 4. The Criminal Complaint obtained during the Department's investigation revealed that the charge stemmed from an incident in which Respondent Jagers used a barbering and cosmetology client's credit card to make purchases without authorization and represented that she was the owner of the credit card.
- 5. Respondent Jagers failed to notify the Department of the conviction within 48 hours after the entry of the judgment of conviction.
- 6. In resolution of this matter, Respondent Jagers consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent Jagers violated Wis. Admin. Code § RL (now SPS) 4.09(2) by failing to notify the Department of a conviction within 48 hours of the judgment of conviction.
- 3. By being convicted of a felony committed while engaged in the practice of barbering or cosmetology as described in the Findings of Fact, Respondent Jagers is subject to discipline pursuant to Wis. Stat. § 454.15(2)(d).

#### **ORDER**

### NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. The barbering and cosmetology manager license of Respondent Jagers (license number 81-32863) is hereby SUSPENDED for a period of 60 days beginning 15 days after the date of this Order.
- 3. The barbering and cosmetology manager license of Respondent Jagers (license number 81-32863) is hereby LIMITED for 5 years beginning 15 days after the date of this Order as follows:
  - a. Respondent Jagers is prohibited from personally receiving, holding or disbursing credit cards, money, funds or anything of material value while practicing barbering and cosmetology.

- b. Respondent Jagers shall show this Order to all barbering and cosmetology employers during the period of license limitation.
- 4. Within 90 days of the date of this Order, Respondent Jagers shall pay COSTS of this matter in the amount of \$293.00.
- 5. Costs in this matter shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, Respondent's license (no. 81-32863) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
