By Order dated June 11, 2012, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondent to pay proceeding costs in the amount of one hundred forty five (\$145) dollars and a forfeiture of one thousand two hundred (\$1,200) dollars. The Respondent was to make these payments in installments of three hundred thirty-six dollars and twenty five cents (\$336.25), with the first payment due on the 15th day of the month following the date of the Order.

According to records maintained by the Department of Safety and Professional Services, the Respondent has failed to pay the first installment by the due date (July 15, 2012).

Pursuant to the terms of the June 11, 2012 Order, failure to make the payment as required constitutes a violation of the Order and may result in suspension of the Respondent's licensee without further notice or hearing.

Based upon the entire record in the above-captioned matter, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Mary Schatzman's practitioner license (#70842-82) is SUSPENDED until she has complied with payment of costs and forfeitures as set forth in the June 11, 2012 Order.

This Order is effective five (5) days from the date hereof.
