By Order dated June 11, 2012, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondent Moore to pay a forfeiture of two hundred dollars (\$200) and costs of the proceeding (costs) of one hundred fifty three dollars (\$153). Respondent Handsome Barber Shop was ordered to pay a forfeiture of two hundred dollars (\$200) and costs of the proceeding (costs) of one hundred fifty three dollars (\$153). The Respondents were to pay the forfeitures and costs within ninety (90) days following the date of the Order.

According to records maintained by the Department of Safety and Professional Services, the Respondents have failed to make any payments.

Pursuant to the terms of the June 11, 2012 Order, failure to make the payments as required constitutes a violation of the Order and may result in suspension of the Respondents' license without further notice or hearing.

Based upon the entire record in the above-captioned matter, the Board makes the following:

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Thaddeus E. Moore's manager license (#24739-81) is SUSPENDED until he has complied with payment of costs and forfeitures as set forth in the June 11, 2012 Order.

IT IS FURTHER ORDERED that Handsome Barber Shop's establishment license (#36933-80) is SUSPENDED until it has complied with payment of costs and forfeitures as set forth in the June 11, 2012 Order.

This Order is effective five (5) days from the date hereof.
