The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Christina D. Jackson, R.C.P., ("Respondent") also known as Christina D. Powell, was born on April 7, 1986 and is a licensed respiratory care practitioner in the State of Wisconsin (license #4068-28). This license was first granted on October 18, 2010 and is current through June 30, 2012.

- 2. Respondent's most recent address on file with the Wisconsin Medical Examining Board is 9335 West Sheridan Avenue, Apartment #4, Milwaukee, Wisconsin.
- 3. On August 31, 2010, Respondent signed a Consent Order (North Carolina Order) with the North Carolina Respiratory Care Board. The North Carolina Order stated that Respondent committed professional misconduct by making a change in ventilator settings without a physician order or approved facility protocol.
- 4. On September 7, 2010, the North Carolina Respiratory Care Board accepted the Consent Order. Respondent was Reprimanded and assessed a civil penalty.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent, by having disciplinary action taken against her North Carolina Respiratory Care Practitioner license, has committed unprofessional conduct as defined by Wis. Admin. Code § Med 10.02(2)(q) and is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The stipulation of the parties is approved.

IT IS FURTHER ORDERED that:

- 2. Respondent, Christina D. Jackson, R.C.P., is **REPRIMANDED**.
- 3. Within ninety (90) days of the date of this Order, Respondent shall pay costs of this proceeding in the amount of TWO HUNDRED DOLLARS (\$200.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services and mailed to:

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may impose additional conditions and

limitations or other additional discipline for a violation of any of the terms of this Order. In the event that Respondent fails to timely submit payment of the costs as ordered, Respondent's license (#4068-28) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has paid costs.

5. This Order is effective on the date of its signing.
