The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board (Section). The Section has reviewed the attached Stipulation and considered it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Patricia K. Danielson, (DOB 01/15/1944), is credentialed as a social worker in the State of Wisconsin pursuant to credential number 3569-120. Respondent's credential was first granted on May 12, 1994.

2. Respondent's most recent address on file with the Department of Safety and Professional Services (Department) 508 Hickory Street, Fort Atkinson, WI 53538.

3. On or about January 20, 2011, Respondent renewed her social worker credential in the State of Wisconsin. During the Continuing Education Certification portion of the renewal process, Respondent attested to the following statement:

I have completed 30 credit hours of continuing education in approved programs as provided in section MPSW 19.01, Wisconsin Administrative Code, between March 1, 2009 and February 28, 2011. I have or will have evidence of this which I will furnish to the Board upon request.

4. In July 2011, as a result of a continuing education audit conducted on behalf of the Section, the Department requested that Respondent submit an attendance table, and proof of attendance, that included the continuing education hours she completed during the 2009-2011 credentialing period.

5. Respondent submitted her attendance table, which indicated that Respondent completed 22 continuing education hours (CEH), however Respondent only provided sufficient proof of completion for 8 CEH.

6. Respondent has retired and no longer uses her social worker credential.

CONCLUSIONS OF LAW

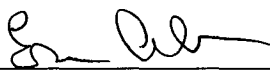
1. The Section has jurisdiction to act in this matter, pursuant to Wis. Stat. § 457.26, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

IT IS HEREBY ORDERED that:

1. The Stipulation of the parties is approved.
2. The voluntary SURRENDER of Patricia K. Danielson's social worker credential, no. 3569-120, is accepted.
3. Patricia K. Danielson will not reapply for certification in the state of Wisconsin at any time in the future and the Department of Safety and Professional Services will not process any application for renewal of the credential of Patricia K. Danielson.
4. This Order shall become effective on the date of its signing.
