The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Kristi J. Kielstrup, R.N., (DOB 06/08/1949) is licensed as a professional nurse in the State of Wisconsin (license no. 85618-30). This license was first granted on September 1, 1983.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is W7928 Norway Road, Elroy, WI 53929.

3. On July 14, 2009, while working as a professional nurse at Heritage Manor in Elroy, Wisconsin, Respondent attempted to give oral medication to an unresponsive resident and failed to call 911 or a physician when the resident could not be aroused during a hypoglycemic episode.

4. According to Respondent, another nurse had used up the only glucagon in contingency and she did not know that the resident had refused lunch and dinner. Respondent admits that she should have called 911 or a physician.

5. Respondent has retired from the practice of nursing and will not return to the practice due to medical reasons.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

IT IS ORDERED:

1. The voluntary SURRENDER of the license of Kristi J. Kielstrup to practice nursing in the State of Wisconsin is hereby accepted.

2. The voluntary SURRENDER of the privilege of Kristi J. Kielstrup to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent re-applies for licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted shall be in the discretion of the Board.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of three hundred fifty dollars (\$350.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services, and mailed to:
