The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Applicant Sharkise D. Dundy's most recent address on file with the Department is 3615 W. North Ave., Milwaukee, WI 53208.
2. In May 2012, Applicant Dundy submitted an application for a private security person permit to the Department.
3. Information received in the application process reflects that on or about December 16, 2008, Applicant Dundy was convicted of misdemeanor Possess Dangerous Weapon-Person < 18. Applicant Dundy was sentenced to one year probation.

4. On or about June 12, 2012, the Department sent Applicant Dundy a Notice of Denial for a permit to practice as a private security person in Wisconsin. The reason for the denial was that Applicant Dundy was convicted of a crime, the circumstances of which substantially relate to the private security profession.

5. On or about June 25, 2012, the Department received a letter from Applicant Dundy requesting a hearing on the denial of his application for a private security person permit.

6. Limitations on Applicant Dundy's private security person permit are necessary to ensure the safety and welfare of the public.

7. In resolution of this matter, Applicant Dundy consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. The facts and circumstances of the conviction referenced above substantially relate to the practice of a private security person. Applicant Dundy, by his conduct, is subject to action against his license pursuant to Wis. Stat. § 440.26.

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The attached Stipulation is hereby accepted.
2. Applicant Dundy is hereby GRANTED a Private Security Person Permit subject to the following LIMITATIONS, TERMS AND CONDITIONS:
  - a. Applicant Dundy shall provide a copy of this Final Decision and Order immediately to supervisory personnel at all settings where Applicant Dundy gains employment as a private security person.
  - b. Applicant Dundy shall not apply for or be granted a firearms permit by the Department for at least one year from the effective date of this Order.
  - c. Applicant Dundy shall not be permitted to carry a firearm in conjunction with his employment as a private security person for at least one year from the effective date of this Order.
  - d. Applicant Dundy may petition the Department for removal of these limitations after one year from the effective date of this Order. Removal of these limitations shall be granted if Applicant Dundy has not violated any law the circumstances of which substantially relate to the practice of a private security person since the effective date of this Order.


3. Any petitions for removal of the license limitations shall be sent to the Department Monitor at the address below:

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.

5. This Order is effective on the date of its signing.
