PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Massage Therapy and Bodywork Therapy Affiliated Credentialing Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Scott K. Jordan, Respondent (D.O.B.: January 23, 1952), is licensed and currently registered by the Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board to practice massage and bodywork therapy in the state of Wisconsin pursuant to license number 2010-046. Respondent's license was first granted on April 16, 2001, and expires February 28, 2013.

2. Respondent's last address reported to the Department of Safety and Professional Services is 5430 Monona Drive #201, Monona, Wisconsin 53716.

3. At all times relevant to the incidents described below, Respondent was employed as an instructor at the Tibia Massage School and was self-employed as a massage therapist in Madison, Wisconsin.

4. In 2004, Respondent engaged in a sexual relationship with Patient A, a massage therapy client. In July of 2006, Respondent failed to observe appropriate draping technique with Patient B, who was also a massage therapy client.

5. The Board has not made a determination as to the validity of the allegations.

6. Respondent is not currently practicing as a massage therapist and does not intend to do so in the state of Wisconsin in the future.

CONCLUSIONS OF LAW

1. The Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 460.14, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

IT IS HEREBY ORDERED that:

1. The Stipulation of the parties is approved.

2. The VOLUNTARY SURRENDER of Scott K. Jordan's license to practice massage and bodywork therapy in the state of Wisconsin is accepted, effective the date of this order.

3. Scott K. Jordan will not reapply for registration to practice as a massage and bodywork therapist in the State of Wisconsin at any time in the future and that the Department of Safety and Professional Services will not process any application for renewal of the certificate of Scott K. Jordan, from the date of this Order.
