The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Coolcuts is licensed in the State of Wisconsin as a barbering or cosmetology establishment, having license number 37552-80, first issued on 04/29/2010 and expired on 3/31/2011. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 6807 W. Hampton Ave., Milwaukee, WI 53218.
- 2. On July 20, 2010, Respondent was inspected under the Board's new establishment inspection program. Various cleanliness codes were noted to be violated.

Violations included that licenses were not being posted, the floor was not swept, clean contact equipment was being kept in the open, and there was no blood exposure protocol posted. The owner, Jumarrow Stanton was issued a Notice of Compliance which he failed to return.

- 3. Amy A. Sims was the manager of Coolcuts from April 2010 to August 2010. Mr. Stanton did not notify the board that Ms. Sims was no longer the manager within 10 days as required.
- 4. On February 18, 2011, a Department investigator visited Coolcuts. Mr. Stanton told the inspector that Michael Shaffer (license number 32182-81) was the responsible manager but Shaffer was not present at the time of inspection. Mr. Shaffer is also the responsible manager for Elite Studios which is owned by an unrelated party.
- 5. Mr. Stanton stated that there were four men working there as apprentices including Larry Hanson and Courtney Vaughn and two unidentified men.
- 6. There are no records of valid apprentice permits issued to Larry Hanson, Courtney Vaughn or anyone else at Respondent Coolcuts.
- 7. On June 22, 2011, the establishment was again visited by a Department investigator. Shaffer identified himself as the manager. Both Shaffer's license and the establishment license for Coolcuts were expired as of 4/1/2011.
- 8. There were several men in Coolcuts cutting hair. The investigator was told by Stanton that those men had finished their schooling but had not yet gotten their licenses.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code §§ BC 2.045(1) and BC 3.01 by allowing the practice of barbering or cosmetology outside of a licensed establishment.
- 3. By the conduct described in the Findings of Fact, Respondent violated Wis. Stat. § 454.08(6) and Wis. Admin. Code §§ BC 2.06(5) and 3.02(1) by not notifying the board that Ms. Sims was no longer the responsible manager and not employing a manager who holds a manager license and works full time in the establishment.
- 4. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code §§ BC 2.07(2) failure to post licenses, 4.01(1) all areas of an establishment and the equipment used for services shall be maintained in a clean, sanitary and safe condition, 4.02 (4) clean and disinfected contact equipment shall be kept in covered containers, and 4.05 written blood exposure protocol shall be posted in a conspicuous place as noted in the Notice of Violation from the July 20, 2010, inspection.

5. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stats. §§ 454.15(2)(i)and 454.15(3).

<u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. The barbering or cosmetology license of Respondent Coolcuts (license no. 37552-80) is hereby SUSPENDED for 10 days starting the date of its renewal.
- 3. Respondent shall pay a FORFEITURE in the amount of \$2500 and COSTS of this matter in the amount of \$900 pursuant to the following schedule:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered, Respondent's license (no. 37552-80) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the forfeiture and costs.
 - 6. This Order is effective on the date of its signing.
