The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Amy F. Vangrinsven (dob 03/20/1973) is licensed in the State of Wisconsin as a barbering and cosmetology manager, having license number 27775-81, first issued on 03/25/1999 and current through 03/31/2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 417 West Third St., Kimberly, WI 54136.
- 2. On February 26, 2012, a complaint was received by the Department that Respondent was renting chairs/booths to two people who did not have a manager licenses.
 - 3. On June 21, 2012, a Department investigator visited the salon.

- 4. Respondent stated that the renters in question were not now, nor had ever been, her employees, but she was trying to help them out by letting them work at her salon.
- 5. At the time of the investigator's visit, the renters had obtained barbering and cosmetology manager licenses, but had not obtained an establishment licenses for the booth rentals.

CONCLUSIONS OF LAW

- 1. The Wisconsin Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code § BC 3.02(2)(b) by leasing booths to two people who did not hold establishment licenses.
- 3. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. § 454.15(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. Respondent Amy F. Vangrinsven is hereby REPRIMANDED.
- 3. Within 90 days of the date of this Order, Respondent shall pay a FORFEITURE in the amount of \$2000 and COSTS of this matter in the amount of \$230.
- 4. Payment of forfeiture and costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered, Respondent's license (no. 27775-81) may, in the discretion of the Board or its designee,

be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the forfeiture and costs.

6. This Order is effective on the date of its signing.
