RE: Master Electrician License #171531 Notice of SUSPENSION

Dear Mr. Young,

As you are aware, there has been an investigation into allegations that you misrepresented your continuing education (CE) credits to maintain your master electrician's license when you renewed on June 16, 2010. You have admitted that you did submit a 36 hour CE Solar Voltaics course that was held for approximately 4 hours every Thursday night from September 10, 2009 through November 12, 2009. You have admitted that you intended to "make this up" in the future. You have admitted that up until now, almost three years later, you have done nothing to "make this right".

Our records show that for the 2006 to 2010 licensing period you submitted a course ID 10000, NEC Significant Changes which was completed 1/21/2009 and certified for 12 credits. Since your license requires you to successfully complete 24 credits during your cycle, you were required to complete another 12 credits. The only other course the department shows you submitted was entitled "Basic Photovoltaics" which allegedly was completed on 9/10/2009. Given that "Solar Voltaics" began the same day, it appears that this is meant to be the same course. However, to be fair, if you can provide proof of you attending the Basic Photovoltaics course you've listed, you would have reached your 24 credits for that period.

The Department has determined that you violated Wis. Admin. Code § 305.43(7)(b) by not obtaining at least 24 hours of acceptable continuing education within the appropriate time period. Because you misrepresented your compliance with that code, you may be disciplined under Wis. Admin. Code § 305.10(1)(a)2.

Therefore, it is ordered:

- 1. Your license (number 171531) will be **SUSPENDED** beginning on **September 10, 2012**, for the longer of:
 - a. 15 days OR
 - b. Until you successfully prove the completion of 12 hours of continuing education above the NEC Significant Changes course you completed on 1/21/2009 for 12 credits
- 2. Any credits used to fulfill the 4/1/2006 to 3/31/2010 license period will NOT be counted toward any future reporting periods.

3. Your suspension will be lifted upon your submission of a certificate of completion for 12 credits of CE (either taken at once or taken in separate courses). Proof of completion must be sent to the Department Monitor at the address below:

You may request an administrative hearing in writing no later than 30 days after the mailing of this notice in accordance with Wis. Admin. Code § 305.10(1)(d) and Wis. Stats. Chapter 227. That request for hearing must include all reasons why you think this order is in error or they will not be considered at hearing.
