The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Architect Section of the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors (Section). The Section has reviewed this Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent David J. Ewanowski (dob: 02/18/1955) is registered in the State of Wisconsin as an Architect, having registration number 6109-5, first issued on 04/30/1987. Respondent's registration was in expired status from 8/1/2006 until 04/19/2012 but is now current through 7/31/2014. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 621 Williamson St., Madison, WI 53703-3543.
- 2. On January 5, 2012, Respondent self-reported that he had failed to renew his architect registration since 08/01/2006. He admitted to practicing architecture during that time period.

- 3. At the 4/18/2012 meeting of the Architect Section, the Section granted the reinstatement of Respondent's registration.
- 4. In resolution of this matter, consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The of the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors has jurisdiction to act in this matter pursuant to Wis. Stat. § 443., and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, violated Wis. Stat. §§ 443.02(2) and (3) by practicing architecture without a valid registration.
- 3. As a result of the above violations, is subject to discipline pursuant to Wis. Stat. § 443.18.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. Respondent is hereby REPRIMANDED.
- 3. Respondent David J. Ewanowski shall, within thirty (30) days of the date of this Order, pay the MISSED RENEWAL FEES for 2006, 2008, and 2010, totaling TWO HUNDRED TWENTY-FOUR DOLLARS (\$224.00), and calculated as follows:
 - a. \$60 for 2006 renewal, plus
 - b. \$82 for 2008 renewal, plus
 - c. \$82 for 2010 renewal.
- 4. Within 90 days of the date of this Order, shall pay COSTS of this matter in the amount of \$217.
- 5. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of

Respondent's license. The Section in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered and as set forth above, Respondent's registration (no. 6109-5) may, in the discretion of the Section or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.

7. This Order is effective on the date of its signing.
