The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Lorraine E. Miesbauer, R.N., (dob 03/06/1963) is licensed in the State of Wisconsin as a professional nurse, having license number 30-166620, first issued on January 28, 2009, and current through February 28, 2014. Licensee's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is N6654 Beech Road, Shawano, Wisconsin 54166.
- 2. At all times relevant, Licensee was employed as a professional nurse at Sharpe Care Nursing & Rehabilitation, Oconto Falls, Wisconsin.

3. On April 7, 2012, Patient A had incontinent episodes and was experiencing pain due to skin irritation and soreness to the groin area. Medicated ointment and a previous order for a fentanyl patch were used to alleviate the pain. Patient A continued to have increasing occurrences of pain, confusion and agitation. Licensee administered .25mg Ativan to help Patient A relax; however, there was no physician order for the medication.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

- 1. The attached Stipulation is accepted.
- 2. Within six (6) months of the date of this Final Decision and Order, Lorraine E. Miesbauer, R.N., shall, at her own expense, take and successfully complete 2 contact hours on Medication Errors and 2 contact hours on Professional Accountability. Each course attended in satisfaction of this Order must be preapproved by the Board of Nursing or its designee. Licensee shall be responsible for locating a course(s) satisfactory to the Board of Nursing and for obtaining the required approval of the courses from the Board of Nursing or its designee. Within 60 days of completion of this educational requirement, Licensee shall file an affidavit with the Board of Nursing stating under oath that she has attended in its entirety each of the courses approved for satisfaction of this requirement along with supporting documentation of attendance from the sponsoring organizations.
- 3. Within 120 days from the date of this Order, Licensee shall pay costs of this matter in the amount of Three Hundred and Eighty Dollars (\$380.00).
- 4. Proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be mailed, faxed or delivered by Licensee to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Licensee's license. The Board in its discretion may in the alternative impose additional conditions and limitations for a violation of any of the terms of this Order. In the event Licensee fails to timely submit payment of the costs as ordered or fails to submit proof of

successful completion of the ordered education as set forth above, Licensee's license (no. 30-166620) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Licensee has complied with payment of the costs and completion of the education.

6. This Order is effective on the date of its signing.
