PROCEDURAL HISTORY

The parties have agreed to the terms and conditions of the attached Stipulation as an Interim Order in this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order:

FINDINGS OF FACT

1. Respondent David A. Van de Loo, M.D., (dob September 18, 1952), is licensed in the State of Wisconsin to practice medicine and surgery, having license number 20-35288, first issued on April 8, 1994 with registration current through October 31, 2012. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services

(Department) is Mayo Clinic Health System, 1400 Bellinger Street, Eau Claire, Wisconsin 54703.

2. Respondent is certified in general pediatrics with a subspecialty in sports medicine by the American Board of Pediatrics.

3. On September 11, 2012, the Division of Legal Services and Compliance (Division) opened investigation 12 MED 316 of Respondent on behalf of the Board. The investigation is based on allegations by one of Respondent's patients, Patient A, a 16 year old boy. Patient A has alleged that during a physical exam on August 30, 2012, Respondent inappropriately touched Patient A's genitals during the course of the examination.

4. The Board has not made a determination as to the validity of the above allegation.

5. Respondent has voluntarily agreed not to engage in the practice of medicine pending the final resolution of this disciplinary matter.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The license to practice medicine and surgery in the state of Wisconsin of Respondent David A. Van de Loo, M.D., is hereby **SUSPENDED**, during the pendency of this disciplinary matter.

2. The suspension shall end in 10 days unless within that time a Notice of Hearing and Complaint alleging the above conduct has been filed and served in compliance with Wis. Admin. Code §§ RL 2.04 and RL 2.08.

3. The suspension shall continue until one of the following occurs:


a. The Board issues a Final Decision and Order in this disciplinary matter.

b. The assigned administrative law judge or the Board determines, pursuant to Wis. Admin. Code §§ RL 6.10(2) & (3), that the disciplinary proceeding is not advancing with reasonable promptness and the appropriate remedy is to end the suspension.

4. This Order is effective on the date of its signing.
