The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Dona Lundmark, R.N., (DOB 11/05/1956) is licensed as a professional nurse in the State of Wisconsin (license no. 89065-30). This license was first granted on August 21, 1984.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 2501 20th Street, Cumberland, WI 54829.

3. At all times relevant, Respondent was employed as a professional nurse at Amery Regional Medical Center ("Amery") in Amery, Wisconsin.

4. On February 12, 2012, Respondent dispensed two doses of oxycodone but only documented one as given to the patient. Upon questioning by Amery staff, Respondent stated that she must have given the second dose and forgotten to sign it out in the electronic medication administration record.

5. During the night shift on April 25 – 26, 2012, Respondent dispensed two oxycodone/acetaminophen 5 mg/325 mg tablets at 0130 and 0620 and documented that she gave the medication to Patient A.

6. During the morning shift on April 26, 2012, Nurse A conducted a follow-up pain assessment of Patient A during which Patient A indicated that she only received one tablet at 0130 and at 0620.

7. During the night shift on April 26 – 27, 2012, Respondent dispensed two oxycodone/acetaminophen 5 mg/325 mg tablets at 0030 and one tablet at 0639, and documented that she gave the medication to Patient A.

8. During the morning shift on April 27, 2012, Nurse A conducted a follow-up pain assessment of Patient A during which Patient A indicated she only received one tablet.

9. When questioned by Amery staff about the missing tablets, Respondent admitted that she took the medication for her mother, who was under a lot of pain.

10. On April 30, 2012, Amery terminated Respondent's employment.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraphs 4-9 above constitutes a violation of Wis. Admin. Code § N 7.04(2) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

1. Dona Lundmark, R.N., is REPRIMANDED.
2. The license of Dona Lundmark, R.N., to practice nursing in the state of Wisconsin, and her privilege to practice in Wisconsin pursuant to the Nurse Licensure Compact, are LIMITED as follows:
 - a. Respondent, at her own expense, shall complete four (4) hours of pre-approved continuing education in medication administration, and four (4) hours of pre-approved continuing education in nursing ethics, within 90 days of the date of this Order. Respondent is responsible for finding an appropriate course and submitting the course information to the Board for approval prior to taking the course and in sufficient time to obtain board approval within the 90-day time frame, taking into account the board's meeting schedule. Respondent shall provide proof of completion of the continuing education to the Department Monitor.
 - b. Respondent shall provide her nursing employers with a copy of this Order before engaging in any nursing employment.
 - c. For a period of at least one (1) year while working at least half-time as a nurse, Respondent shall not work as a nurse or other health care provider in a setting in which Respondent has access to controlled substances.
 - d. For a period of at least two (2) years while working at least half-time as a nurse, Respondent shall work only under direct supervision, and only in a work setting pre-approved by the Board. Respondent shall not work in a home health, agency or pool position.
 - e. For a period of at least two (2) years while working at least half-time as a nurse, Respondent shall arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance.
 - f. Pursuant to Uniform Nurse Licensure Compact regulations, Respondent's nursing practice is limited to Wisconsin during the pendency of this limitation. This requirement may be waived only upon the prior written authorization of both the Wisconsin Board of Nursing and the regulatory board in the state in which Respondent proposes to practice.
 - g. Respondent shall notify the Department Monitor of any change of nursing employment during the time in which the Order is in

effect. Notification shall occur within fifteen (15) days of a change of employment and shall include an explanation of the reasons for the change.

3. After one (1) year of working at least half-time as a nurse, Respondent may petition the board for the modification or termination of the limitation. The Board may grant or deny the petition, in its discretion, or may modify this Order as it sees fit.

4. Respondent shall, within one hundred twenty (120) days of the date of this Order, pay to the Department of Safety and Professional Services costs of this proceeding in the amount of Three Hundred Dollars (\$300.00) pursuant to Wis. Stat. § 440.22(2).

6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that Respondent fails to timely submit payment of the costs as ordered or fails to comply with the ordered continuing education as set forth above, Respondent's license (no. 89065-30) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

7. This Order is effective on the date of its signing.
