The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Social Worker Section of the Marriage & Family Therapy, Professional Counseling & Social Work Examining Board (Section). The Section has reviewed this Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Amy S. Mehlberg (dob June 26, 1966) is licensed in the State of Wisconsin as a certified social worker, having certificate number 699-120, first issued on August 18, 1993, and current through February 28, 2013. Amy S. Mehlberg's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 700 Jones Avenue, Oconto, WI 54153.

2. On November 30, 2010, Respondent misrepresented the completion of documentation in three files assigned to her.

CONCLUSIONS OF LAW

- 1. The Social Worker Section of the Marriage & Family Therapy, Professional Counseling & Social Work Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 457.26, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Amy S. Mehlberg violated Wis. Admin. Code § MPSW 20.02(7) by misrepresenting the completion of documentation in three files assigned to her.
- 3. As a result of the above violations, Amy S. Mehlberg is subject to discipline pursuant to Wis. Stat. § 457.26(2)(f).

ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent Amy S. Mehlberg. is REPRIMANDED.
- 3. Within 90 days from the date of this Order, Amy S. Mehlberg shall pay COSTS of this matter in the amount of \$100.00.
- 4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Section in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered, Respondent's certificate (no. 699-120) may, in the discretion of the Section or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the forfeiture and costs.

6. This Order is effective on the date of its signing.
