On June 12, 2002, the Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice pharmacy in the state of Wisconsin for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On May 22, 2013, the Board reviewed Respondent's monitoring history and the recent reinstatement of his license to practice pharmacy in the state of Minnesota to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's license to practice pharmacy in the state of Wisconsin (#12304-40) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
