On October 8, 2002, the Pharmacy Examining Board issued a Final Decision and Order reprimanding Sniteman Pharmacy, Inc., David Klieforth, R.Ph. and William Weiler, R.Ph. The Board further limited all three licenses, prohibiting them from dispensing any C-V substance without a prescription order from an authorized practitioner.

On February 13, 2013, the Board considered Respondents' petition for removal of the limitation on each license. Based upon the information of record, which demonstrates Respondents' compliance with the terms of the Order, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that licenses of Sniteman Pharmacy, Inc. (#7029-42), David Klieforth, R.Ph. (#10525-40) and William Weiler, R.Ph. (#8304-40) are hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondents' credentials be, and hereby are, removed.

This Order is effective the date of its signing.
