On September 8, 2005, the Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license in the state of Wisconsin for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On September 12, 2013, the Board considered Respondent's request for full reinstatement of her license. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's professional nursing license in the state of Wisconsin (#85188-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
