On December 13, 2007, the Board of Nursing issued a Final Decision and Order indefinitely suspending Respondent's license (#146549-30) to practice nursing in the state of Wisconsin. The Board subsequently granted a stay of suspension, permitting Respondent to practice under a limited license with certain terms and conditions.

On March 14, 2013, the Board considered Respondent's petition for the return of full licensure. Based upon the information of record, which demonstrates that Respondent has been compliant with the terms and conditions of the Order and thereby qualifies for full licensure, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's license to practice nursing in the state of Wisconsin (#146549-30) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
