On January 9, 2008, the Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice dentistry in the state of Wisconsin (#5001336-15) for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On May 1, 2013, the Board considered Respondent's request for the return of full licensure. Based upon the information of record, including evidence that Respondent has demonstrated continuous compliance with the terms and conditions of the Order and qualifies for full licensure, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's license to practice dentistry in the state of Wisconsin (#5001336-15) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
