On February 21, 2008, the Real Estate Examining Board reprimanded Respondent, suspended her license to practice as a real estate broker for 45 days and limited her license with certain terms and conditions. The limitation requirements were later modified, pursuant to the Board Order issued on July 5, 2011.

On August 22, 2013, the Board considered Respondent's request to remove the limitation from her license. Based upon the information of record, which includes evidence of Respondent's compliance with the terms of the orders dated February 21, 2008 and July 5, 2011, the Board finds and makes the following:

ORDER

1. Respondent's license to practice as a real estate broker in the state of Wisconsin (#52261-90) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This Order is effective the date of its signing.
