On March 19, 2008, the Medical Examining Board issued a Final Decision and Order indefinitely suspending Respondent's certification to practice respiratory care in the state of Wisconsin (#423-28). The Board simultaneously granted a stay of suspension, permitting Respondent to practice under a limited license with certain terms and conditions.

On March 20, 2013, the Board considered Respondent's request for the return of full licensure. Based upon the information of record, including evidence that Respondent has demonstrated continuous compliance with the terms and conditions of the Order and qualifies for full licensure, the Board finds and makes the following:


ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's certification to practice respiratory care in the state of Wisconsin (#423-28) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
