By Order dated April 7, 2008, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondents' Tho Thi Bui and Nail Art to jointly and severally pay a forfeiture of four thousand five hundred dollars (\$4,500) and costs of the proceeding (costs) of four hundred fifty dollars (\$450) for a total of four thousand nine hundred fifty dollars (\$4,950). The Respondents were to make payments in installments of five hundred dollars (\$500) on July 15, 2008; October 15, 2008; January 15, 2009; April 15, 2009; July 15, 2009; October 15, 2009; January 15, 2010; April 15, 2010; and July 15, 2010; and a payment of four hundred fifty dollars (\$450) on October 15, 2010.

According to records maintained by the Department of Safety and Professional Services, the Respondents have failed to make payments totaling two thousand five hundred fifty dollars (\$2,550).

Pursuant to the terms of the April 7, 2008, Order, failure to make the payments as required constitutes a violation of the Order and may result in suspension of the Respondent's license without further notice or hearing.

Based upon the entire record in the above-captioned matter, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Nail Art's establishment license (#3198-71) is SUSPENDED until it has complied with payment of costs and forfeitures as set forth in the April 7, 2008, Order.

This Order is effective five (5) days from the date hereof.
