On February 13, 2013, the Pharmacy Examining Board considered Respondent's petition for a reduction in the frequency of drug and alcohol screens and termination of the drug and alcohol treatment requirement, both imposed pursuant to the Final Decision and Order dated October 29, 2008. Based upon the information of record, which includes proof of Respondent's compliance with the Order and a written recommendation from her Treater supporting the modifications sought, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. The frequency shall be reduced to 14 screens per year plus one annual hair test until Respondent obtains employment as a pharmacist, at which time the frequency will be increased to 48 screens per year plus one annual hair test.

IT IS FURTHER ORDERED that Respondent's request for termination of the drug and alcohol treatment requirement is hereby GRANTED.

All other terms and conditions remain in full force and effect.

This Order is effective the date of its signing.
