On April 27, 2011, Respondent's license to practice as a barbering and cosmetology manager was suspended for failure to pay the costs of the proceeding and forfeiture, pursuant to the Final Decision and Order dated November 3, 2008. ORDER

1. The suspension of Respondent's license to practice as a barbering and cosmetology manager (#30385-81) is terminated.
2. Respondent's license is hereby reinstated to full, unrestricted status. All limitations and encumbrances upon Respondent's credential pursuant to the Order are removed.
