On February 26, 2009, the Board of Nursing ("Board") issued a Final Decision and Order ("Order") revoking Respondent's professional nursing license in the state of Wisconsin. Respondent's license was subsequently reinstated and limited with certain terms and conditions, pursuant to the Order Granting Reinstatement and Limited License issued April 3, 2012.

On October 10, 2013, the Board considered Respondent's request for termination of the drug and alcohol treatment requirement and a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of the drug and alcohol treatment requirement is hereby GRANTED.
2. Respondent's request for a reduction in the frequency of drug and alcohol screens is hereby DENIED due to insufficient evidence of compliance, secondary to the positive drug screens in 2013.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
