On April 1, 2013, the Cosmetology Examining Board considered the Respondents' request for a payment plan to pay the forfeiture pursuant to the Citation Default Final Decision and Order of the Board dated April 6, 2009. Based upon the information of record, the Board now finds and makes the following:

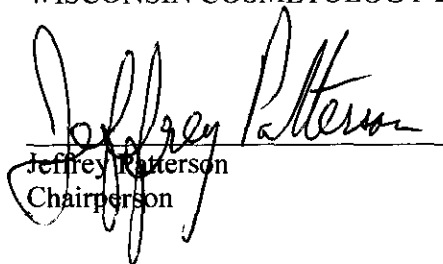
ORDER

NOW, THEREFORE, IT IS ORDERED that the Respondents' request for a payment plan to pay the forfeiture is GRANTED as follows:

1. Respondents shall make a minimum payment of \$200 commencing May 1, 2013, and shall pay a minimum of \$200 per month thereafter until the total amount of Respondents' \$2,600 obligation is satisfied.
2. Failure to make any required payment shall be presumptive evidence of a violation of the Board's Order, which may result in further disciplinary action.
3. All provisions of the April 6, 2009, Order not otherwise modified herein shall remain in full force and effect.
