On April 16, 2009, the Wisconsin Social Worker Section ("the Section") issued a Final Decision and Order suspending Respondent's advanced practice social worker certificate for an indefinite period. Respondent was required to satisfy certain conditions prior to petitioning the Section for termination of the suspension.

On May 23, 2012, the Section considered Respondent's petition for termination of the suspension. The Section denied Respondent's request due to insufficient evidence demonstrating that he is able to practice with reasonable skill and safety of clients and does not suffer from any condition that would prevent him from doing so.

On April 10, 2013, the Section considered Respondent's second request for termination of the suspension. Based on the information of record, including recommendations from Drs. Gary Schoener and James Gerndt, the Section finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's request to terminate the suspension of his advanced practice social worker certificate in the state of Wisconsin (#474-121) is hereby GRANTED.
