On July 23, 2009, the Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license in the state of Wisconsin for an indefinite period. The Board has granted a stay of suspension, permitting Respondent to practice under a limited license with certain terms and conditions.

On September 12, 2013, the Board considered Respondent's request to reduce, or terminate, the requirement for drug and alcohol screens and to reduce the requirement for AA/NA meetings. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to 14 urine screens per year and one annual hair test.
2. Respondent's request for a reduction in the AA/NA attendance requirement is hereby DENIED. Due to the termination of drug and alcohol treatment, the ongoing support of AA/NA is necessary to prevent relapse.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
