On August 18, 2010, the Medical Examining Board issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery in the state of Wisconsin (#37385-20) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 20, 2013, the Medical Examining Board considered Respondent's request for a reduction in the annual frequency of drug and alcohol screens, required pursuant to the Order. Based upon the information of record, which includes evidence of insufficient time under the terms of the Order, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's request for modification of the terms, specifically a reduction in the annual frequency of drug and alcohol screens, is hereby DENIED.
