On September 2, 2010, the Board of Nursing issued a Final Decision and Order ("Order") indefinitely suspending Respondent's professional nursing license the state of Wisconsin (#101404-30). Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On August 8, 2013, the Board of Nursing considered Respondent's request to terminate alcohol and drug treatment requirement and reduce the frequency of drug and alcohol screens required pursuant to the Order. Based upon the information of record, which demonstrates Respondent's compliance with the terms and conditions of the Order and the support of her treatment provider for the modifications sought, the Board finds and makes the following:

ORDER

IT IS HEREBY ORDERED that:

1. Respondent's request for termination of the drug and alcohol treatment requirement is GRANTED.
2. Respondent's request for a modification to the frequency of drug and alcohol screens is GRANTED. Respondent shall now undergo drug and alcohol screens at a frequency of not less than 14 times per year plus one annual hair test.
3. All other terms and conditions of the September 2, 2010 Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
