On November 1, 2010, the Cosmetology Examining Board ordered Respondent to pay a forfeiture in the amount of \$3,000 and costs in the amount of \$220 on a scheduled payment plan.

On June 24, 2013, the Cosmetology Examining Board considered Respondent's request for an extension of time to pay on the payment plan pursuant to the Final Decision and Order of the Board dated November 1, 2010. In support of his request, Respondent submitted a payment of \$300. Based upon the information of record, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the Respondent's request for an extension of time to pay on the existing payment plan to pay the forfeiture and proceeding costs is GRANTED as follows:

- 1. Respondent shall make a minimum payment of \$300 commencing August 1, 2013, and shall pay of \$300 every 90 days thereafter until the total amount of Respondent's \$600 obligation is satisfied.
- 2. All provisions of the November 1, 2010, Order not otherwise modified herein shall remain in full force and effect.
