On January 31, 2011, the Cosmetology Examining Board¹ ordered Respondents to pay one thousand two hundred two dollars and thirty seven cents (\$1,202.37) each in proceeding costs and forfeiture within ninety (90) days. On April 11, 2013, the Board granted Respondents a payment plan to pay the proceeding costs and forfeitures.

The information of record demonstrates that Respondents have failed to pay the costs and forfeitures as ordered and, as a result, the following is entered:

ORDER

1. Respondent Flair Designs, LLC's license (#34334-80) is SUSPENDED. Respondent La Tanya S. Peel's license (#28971-81) is SUSPENDED.

2. The suspensions shall remain effective until Respondents have paid the proceeding costs and forfeiture in full as ordered by the Board on January 31, 2011.
