On January 31, 2011, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent Flair Designs LLC to pay \$452.37 in costs of the proceeding and a forfeiture of \$750.00 within 90 days. Respondent La Tanya Peel was also required to pay \$452.37 in costs of the proceeding and a forfeiture of \$750.00 within 90 days. On October 15, 2013, Respondent Flair Designs LLC establishment license #34334-80 was suspended for failure to pay the costs of the proceeding and forfeiture as ordered. On October 15, 2013, Respondent La Tanya Peel's manager license #28971-81 was suspended for failure to pay the costs of the proceeding and forfeiture as ordered.

Based upon the information of record, which includes proof that Respondents have now paid the costs of the proceeding and forfeitures in full, the following is entered:

ORDER

1. The suspension is terminated and Respondent Flair Designs LLC establishment license (#34334-80) is hereby returned to full, unrestricted status. Respondent La Tanya Peel's manager license (#28971-81) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondents' credentials are removed.
3. This order is effective the date of its signing.
