By Order dated April 4, 2011, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondent to pay a forfeiture of five hundred dollars (\$500) and costs of the proceeding (costs) of two hundred fifty-five dollars (\$255) for a total of seven hundred fifty-five dollars (\$755). The Respondent was to make a down payment of two hundred fifty-five dollars (\$255) within 30 days following the date of the Order and make two (2) more payments of two hundred fifty dollars (\$250) due every ninety (90) days from the date of the previous due date.

According to records maintained by the Department of Safety and Professional Services, the Respondent has failed to make the two (2) payments of two hundred fifty dollars (\$250).

Pursuant to the terms of the April 4, 2011, Order, failure to make the payments as required constitutes a violation of the Order and may result in suspension of the Respondent's license without further notice or hearing.

Based upon the entire record in the above-captioned matter, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Jasmine M. Flowers' manager license (#33048-81) is SUSPENDED until she has complied with payment of costs and forfeitures as set forth in the April 4, 2011, Order.

This Order is effective five (5) days from the date hereof.
