On July 21, 2011, the Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license in the state of Wisconsin (#125111-30) for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On August 8, 2013, the Board considered Respondent's request for a reduction in the annual frequency of drug and alcohol screens, required pursuant to the Order. Based upon the information of record, which demonstrates insufficient time to show compliance with the terms of the Order, the Board finds and makes the following:

ORDER

IT IS HEREBY ORDERED that Respondent's request for modification of the terms, specifically a reduction in the frequency of drug and alcohol screens, is DENIED.
