By Order dated September 12, 2011, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondent Hoang T. Nguyen to pay a forfeiture of one thousand four hundred twenty-five dollars (\$1,425) and costs of the proceeding (costs) of two hundred eleven dollars (\$211). Respondent Supreme Nails was ordered to pay a forfeiture of one thousand four hundred twenty-five dollars (\$1,425) and costs of the proceeding (costs) of two hundred eleven dollars (\$211). The Respondents were to pay the forfeitures and costs within ninety (90) days following the date of the Order.

On February 9, 2012, the Board granted Respondents' requests for a payment plan. Respondent Hoang T. Nguyen was to make a payment of not less than five hundred dollars (\$500) within 30 days following the date of the Order and make payments in the amount of two hundred fifty dollars (\$250) monthly thereafter until the total amount of fines and costs assessed against Nguyen had been paid. Respondent Supreme Nails was to make a payment of not less than five hundred dollars (\$500) within 30 days following the date of the Order and make payments in the amount of two hundred fifty dollars (\$250) monthly thereafter until the total amount of fines and costs assessed against Supreme Nails had been paid.

According to records maintained by the Department of Safety and Professional Services, the Respondents, collectively, have made one payment on February 29, 2012, totaling two hundred dollars (\$200).

Pursuant to the terms of the February 9, 2012, Order, missed payments by either Respondent will be grounds for immediate suspension.

Based upon the entire record in the above-captioned matter, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Hoang T. Nguyen's manicurist license (#6175-85) is SUSPENDED until he has complied with payment of costs and forfeitures as set forth in the September 12, 2011, and February 9, 2012, Orders.

NOW, THEREFORE, IT IS HEREBY ORDERED that Supreme Nails' manicuring establishment license (#3708-71) is SUSPENDED until it has complied with payment of costs and forfeitures as set forth in the September 12, 2011, and February 9, 2012, Orders.

This Order is effective five (5) days from the date hereof.
