On March 20, 2013, the Medical Examining Board considered Respondent's request for removal of the limitation on his license to practice medicine and surgery in the state of Wisconsin, imposed pursuant to the Final Decision and Order dated March 21, 2012 ("Order"). Respondent, accompanied by his attorney, appeared before the Board in support of his request. Based upon the information of record, including evidence of compliance and written recommendations from his Treater and current employer, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's license to practice medicine and surgery in the state of Wisconsin (#28574-20) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
