On April 2, 2012, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay two hundred and sixteen dollars (\$216.00) in costs of the proceeding and a forfeiture of two thousand one hundred dollars (\$2,100.00) within ninety (90) days. On December 10, 2012, the Board granted the Respondent a payment plan of two hundred dollars (\$200.00) per month until the total amount was paid in full.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and the forfeiture as ordered and, as a result, the following is entered:

ORDER

1. Respondent's manager license (#32134-81) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding and forfeiture in full.
3. This order is effective the date of its signing.
