On April 2, 2012, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order limiting Respondent's manager license with certain terms and conditions. On December 3, 2013, Respondent's manager license (#32134-81) was suspended due to his failure to pay costs as ordered.
