On April 25, 2012, the Psychology Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice psychology in the state of Wisconsin. Respondent may petition the Board for termination of the suspension after one year under the Order and successful completion of eight hours of education in ethics and boundaries.

On March 25, 2013, the Board considered Respondent's request for termination of the suspension. Based upon the information of record, which demonstrates insufficient time under the Order, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's request to terminate the suspension of his license to practice psychology in the state of Wisconsin (#2287-57) is hereby DENIED.

IT IS FURTHER ORDERED that the suspension may be terminated by the Department Monitor on April 25, 2013, when Respondent has completed one year under the Order, without further notice, hearing or action from the Board.

This Order is effective the date of its signing.
