On April 25, 2012, the Psychology Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice psychology in the state of Wisconsin. Pursuant to the Order, Respondent may petition the Board for termination of the suspension after one year and successful completion of eight hours of education in ethics and boundaries.

On March 25, 2013, the Board denied Respondent's request for termination of the suspension due to insufficient time under the Order. The Board further determined that the suspension may be terminated, without further notice, hearing or action, when Respondent has completed one full year under the Order. As of today's date, the one-year requirement has been satisfied and, as a result, the following is entered:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the suspension of Respondent's license to practice psychology in the state of Wisconsin (#2287-57) is hereby terminated.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Respondent's credential be, and hereby are, removed.
