On June 11, 2012, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay one thousand five hundred dollars (\$1,500.00) in costs of the proceeding and one thousand three hundred dollars (\$1,300.00) in forfeiture on a scheduled payment plan. On January 28, 2013, Respondent's license was suspended for failure to make the scheduled payments.

On April 11, 2013, the Board lifted the suspension and granted Respondent a modified payment plan ordering him to make monthly payments of \$100 until the balance is paid in full. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and forfeiture as ordered. As a result, the following is entered:

#### **ORDER**

- 1. Respondent's manager license (#28641-81) is hereby SUSPENDED.
- 2. The suspension shall remain in effect until Respondent is current with the payment plan established on April 11, 2013.
  - 3. This order is effective the date of its signing.
