The Wisconsin Cosmetology Examining Board suspended Respondents' barbering and cosmetology licenses pursuant to Order dated June 11, 2012. Documentation of payment of all forfeitures and costs, in support of Respondents' requests for full licensure, was reviewed on January 28, 2013. Accordingly, the following order is entered:

NOW, THEREFORE, IT IS HEREBY ORDERED that Thaddeus E. Moore is hereby granted full reinstatement of license #24739-81 to practice as a barbering and cosmetology manager and that Handsome Barber Shop is hereby granted full reinstatement of license #80-36933 to practice as a barbering and cosmetology establishment in the state of Wisconsin.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Thaddeus E. Moore and Handsome Barber Shop's licenses are hereby removed.
