On January 9, 2013, the Department of Safety and Professional Services considered the Respondent's request to lift the suspension of the Respondent's acupuncturist license pursuant to the Final Decision and Order of the Department dated June 21, 2012. Based upon the information of record, which shows evidence that the Respondent completed an assessment by a mental health care provider approved by the Department and successfully completed the ordered education, the Department now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of Grant Du's license (#551-55) to practice acupuncture in the state of Wisconsin is lifted and Grant Du is granted a LIMITED license, subject to the limitations, terms and conditions enumerated herein.

Practice Limitations

1. Respondent shall provide acupuncture treatment only to adult male clients.

Psychotherapist

2. Respondent shall continue with psychotherapy treatments with James Gerndt, Ph.D., or another psychotherapist preapproved by the Department or its designee, for not less than one year from the date of this Order.

3. Respondent shall arrange for a written report to be submitted from the psychotherapist to the Department Monitor three (3) months from the date of this Order and every six (6) months thereafter, which shall state how many sessions Respondent has attended and the issues addressed in each session with an assessment of the Respondent's progress towards reaching the goals of therapy. The psychotherapist shall promptly notify Department Monitor of any suspected violations of any of the terms and conditions of this Order by Respondent, or if the psychotherapist is no longer treating Respondent.

4. After one year from the date of this Order, Respondent may petition the Department for termination of psychotherapy with the written support of his psychotherapist.

Required Reporting by Respondent

5. Respondent is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others.
6. Respondent shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change.

Costs

7. Respondent shall pay the costs of ONE THOUSAND SIX HUNDRED DOLLARS (\$1,600) due June 21, 2013, as previously ordered in the Final Decision and Order dated June 21, 2012.

Department Monitor

8. The Department Monitor is the individual designated by the Department as its agent to coordinate compliance with the terms of this Order. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services. Any payments, requests, petitions, reports and other information required by this Order shall be mailed, emailed, faxed or delivered to:

Summary Suspension / Additional Discipline

9. Violation of any of the terms of this Order and/or any further criminal conviction may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to pay costs as set forth above in a timely matter, the Respondent's license (#551-55) may, in the discretion of the Department, or its designee, be SUSPENDED, without further notice or hearing, until Respondent has paid costs.
