On September 19, 2012, the Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery in the state of Wisconsin (#25006-20) for an indefinite period. Prior to applying for reinstatement, Respondent must appear before the Board and prove that he is able to safely and competently practice in Wisconsin.

On December 11, 2013, the Board considered Respondent's request for termination of the suspension. Respondent appeared before the Board on behalf of his request. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of the suspension is hereby DENIED. Respondent has not presented to the Board evidence sufficient to establish his ability to safely and competently resume the practice of medicine and surgery.
2. The Board will not consider any request to terminate or rescind the suspension prior to June 30, 2014. The Board finds such timeframe reasonable based upon the fitness for work evaluation completed on November 26, 2013 by Dr. Midcalf; Respondent's failure to fully comply with the terms of the September 19, 2012 Order; Respondent's repeated and current assertions that he did nothing wrong; and Respondent's failure to assume responsibility for his actions that led to the suspension of this license.
3. This order is effective the date of its signing.
