On October 29, 2012, the Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") suspending Respondent's clinical substance abuse counselor and independent clinical supervisor credentials in the state of Wisconsin for an indefinite period. The Department simultaneously granted Respondent an immediate stay of suspension, contingent upon her compliance with the terms and conditions of the Order.

Information received by the Department Monitor demonstrates that Respondent is in substantial or repeated violation of Section C of the Department Order and, as a result, the following is entered:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of suspension is hereby REMOVED and Respondent's clinical substance abuse counselor (#13700-132) and independent clinical supervisor (#15174-135) credentials are hereby SUSPENDED.

IT IS FURTHER ORDERED that Respondent may petition the Department for reinstatement of the stay of suspension upon demonstrating, to the satisfaction of the Department or its designee, compliance with the provisions of Sections C and D of this Order for the most recent three (3) consecutive months.

This Order is effective immediately.
