The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Jacquelyn M. Green (dob January 13, 1988) is licensed in the State of Wisconsin as a Private Security Person, having license number 108-45388, first issued on June 7, 2012 and current through August 31, 2014. Respondent's most recent address on file with the Department is 7916 N. 64th Ct., Milwaukee, WI 53223.

2. In October 2012, Respondent submitted an online renewal application for her private security person license and answered "NO" to the following questions:

In the past two years, have you been convicted of a MISDEMEANOR, OPERATING WHILE INTOXICATED (OWI), a VIOLATION of any federal, state or local law, OR are criminal charges or OWI charges currently pending against you in this or any other state?

In the past two years, have you been convicted of a VIOLATION of ANY federal, state or local law or municipal ordinance that is punishable by a fine or forfeiture in this or any other state, OR are federal, state or municipal charges currently pending against you?

In the past two years, have you been convicted of a FELONY in this state or any other state, OR are FELONY charges currently pending against you?

3. A subsequent Criminal Information Bureau check by the Department revealed a conviction for Respondent.

4. Respondent's private security person license was renewed on October 26, 2012, and the matter was referred to the Division of Legal Services and Compliance. Case number 12 RSG 048 was subsequently opened for investigation.

5. Court records obtained from Respondent and during the Department's investigation revealed that on or about October 4, 2011, Respondent was cited for municipal ordinance violation, Disorderly Conduct (Glendale Police Department, Incident Number 11-020803).

6. Court records obtained from Respondent and during the Department's investigation revealed that on or about May 24, 2012, Respondent was charged with misdemeanor Disorderly Conduct and misdemeanor Obstructing/Resisting an Officer (Milwaukee County Case Number 2012CM002895).

7. On July 17, 2012, Respondent was convicted of misdemeanor Disorderly Conduct. The Obstructing/Resisting an Officer charge was dismissed but read in. Respondent was sentenced, in part, to 60 days House of Corrections (stayed) and one year probation.

8. Respondent failed to notify the Department of the convictions within 48 hours after the judgments finding that she committed a violation.

9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent engaged in conduct reflecting adversely on her professional qualification pursuant to Wis. Admin. Code § RL (now SPS) 35.01(2) by violating laws the circumstances of which substantially relate to the practice of a private security person.

3. By the conduct described in the Findings of Fact, Respondent violated Wis. Stat. § 440.26(4m)(b) and Wis. Admin. Code § RL (now SPS) 35.01(2) by failing to report her convictions to the Department within 48 hours after the judgments finding that she committed a violation.

4. By the conduct described in the Findings of Fact, Respondent engaged in conduct which reflects adversely on her professional qualification pursuant to Wis. Admin. Code § SPS 35.01(17) by providing false information in the application for a credential

5. As a result of the violations noted in the Conclusions of Law, Respondent is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)1-4 and Wis. Admin. Code § SPS 35.01.

#### ORDER

1. The attached Stipulation is accepted.

2. The Private Security Person license of Jacqueline M. Green (license number 108-45388) is hereby SUSPENDED for a period of 30 days beginning 15 days after the date of this Order.

3. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$364.00.


4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent by Respondent to the Department Monitor at the address below:



5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered and as set forth above, Respondent's license (no. 108-45388) may, in the discretion of the Department, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.

6. This Order is effective on the date of its signing.
