Upon consideration of the application record, the results of the oral examination, and the terms and conditions for grant of licensure, the Medical Examining Board (Board) makes the following:

## **FINDINGS OF FACT**

1. Robert S. Shulman, M.D., (DOB 12/28/41) was granted a license to practice medicine and surgery in the State of Wisconsin (License # 19723-20) on October 17, 1975.

2. Dr. Shulman did not reregister his license pursuant to Wis. Stat. § 448.07 after the registration of his license expired on December 31, 1981.

3. Pursuant to Wis. Admin. Code § MED 14.06 (2), Dr. Shulman's license lapsed upon his failure to re-register.

4. On July 31, 2012, Dr. Shulman filed an application for re-registration of his lapsed license. (License # 19723-20).

5. Pursuant to the requirements of Wis. Admin. Code § MED 14.06 (2) (b). two members of the Board conducted an oral examination with Dr. Shulman on November 14, 2012, to determine

whether he was competent to practice medicine and surgery in this State. Based upon the results of that oral examination which indicated that Dr. Shulman had not engaged in the practice of medicine for more than three years, Dr. Shulman was referred for a full board oral examination.

6. On December 12.2012, Dr. Shulman appeared before the full Medical Examining Board pursuant Wis. Admin. Code § MED 14.06 (2) (b). At that time, the Board conducted an oral examination and determined that Dr. Shulman successfully completed the examination; however, based upon the period of time Dr. Shulman had not engaged in the practice of medicine and his stated desire to resume practice in the specialty area of psychiatry, the Board further determined that it would grant Dr. Shulman a non-disciplinary limited license to practice medicine and surgery in the State of Wisconsin on the terms and conditions set forth in the Order below.

# CONCLUSIONS OF LAW.

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stats. §§448.06 (1) and 448.07 and Wis. Admin. Code § MED 14.06.

#### ORDER

NOW, THEREFORE, IT IS ORDERED that ROBERT S. SHULMAN, M.D. is GRANTED a non-disciplinary LIMITED license to practice medicine and surgery in the State of Wisconsin subject to the following terms and conditions:

### Practice Restrictions

1. Robert. Shulman, M.D. may not engage in the practice of medicine and surgery in the State of Wisconsin until he has complied with all terms of this Order.

#### Education Requirements

2. Prior to engaging in the practice of medicine and surgery in the State of Wisconsin, Robert Shulman, M.D. shall successfully complete a comprehensive review course, including any testing components, in the medical specialty area of psychiatry.

3. Robert Shulman, M.D. shall be responsible for obtaining the course required under this Order, for providing adequate course descriptions to the Department Monitor listed below and for obtaining pre-approval of the course from the Wisconsin Medical Examining Board Chairman prior to commencement of the course.

4. Following completion of the course identified in paragraph two above, Robert Shulman, M.D. shall file with the Department Monitor certifications from the sponsoring organization verifying his attendance at the required course and successful completion of any testing components of the course.

5. All costs of the educational programs shall be the responsibility of Robert Shulman, M.D.

## **Removal of Limitations**

6. Upon receipt of the certifications, the Board Chairman shall review the submitted information and determine compliance with the requirements of this Order. Upon conclusion by the Board Chairman that Robert Shulman, M.D. has successfully completed all terms of this limited license, Robert Shulman shall receive a full and unencumbered license.

## **Department Monitor**
